# Ordinance Amendment - Parks & Recreation Commission Ordinance

Master Plan Implementation Goals: 3.14

A public hearing was conducted to receive citizen comment regarding the proposed amendment to Chapter 2, <u>Administration</u>, Article IV, <u>Boards and Commissions</u>, Division 3, <u>Parks and Recreation Commission</u>, Section 2-242. <u>Members</u>; <u>appointment</u>, <u>terms</u>, <u>voting</u>, <u>officers</u>, of the Code of Ordinances.

The following person commented regarding the proposed amendment:

Patrice Martin, 615 N. Park Street, said she thought the proposed amendment would present a great opportunity for an area student. She asked if a position description had been developed to provide clear guidance as to the student's role on the Commission. Mayor Teich and Assistant City Manager Amy K. Fuller explained the student role.

Whereas, the Council, after due and legal notice, has met and having heard all interested persons, motion by Mayor Pro-Tem Osika that the following ordinance be adopted:

# **ORDINANCE NO. 847**

AMEND CHAPTER 2, ADMINISTRATION, ARTICLE IV, BOARDS AND COMMISSIONS, DIVISION 3, PARKS AND RECREATION COMMISSION WHEREAS, the City of Owosso, Shiawassee County, Michigan, has established by ordinance, a Parks and Recreation Commission to provide quality park and recreation opportunities based upon cost, efficiency and community need; and

WHEREAS, the Parks and Recreation Commission is currently made up of 7 voting members; and

WHEREAS, it is the desire of the Parks and Recreation Commission to add a Student Member to the Commission: and

WHEREAS, it is the long-standing practice of the City Council to hold a public hearing to receive citizen comment regarding any and all proposed ordinance amendments.

NOW THEREFORE BE IT RESOLVED THAT THE CITY OF OWOSSO ORDAINS:

SECTION 1. AMENDMENT. That Chapter 2, <u>Administration</u>, Article IV, <u>Boards and Commissions</u>, Division 3, <u>Parks and Recreation Commission</u>, Section 2-242. <u>Members</u>; appointment, terms, voting, officers, shall be amended as follows:

Sec. 2-242. - Members; appointment, terms, voting, officers.

- (a) The members of the parks and recreation commission shall consist of seven (7) voting members appointed by the mayor and approved by the council. The mayor or the designee of the mayor, with council approval, shall be an ex-officio member of the commission. The Mayor shall also appoint, with council approval, one (1) student member.
- (b) The seven (7) voting members shall have terms of two (2) years. The first appointment of the seven (7) members shall be staggered so that three (3) members are appointed for a one-year term and four (4) members shall be appointed to two-year terms. Thereafter each appointment of a member shall be for a two-year term unless it is an appointment to fill a vacancy in office that occurs prior to completion of a term. The student member shall serve a term of one (1) year. The ex-officio member of the commission shall serve for an indefinite term at the pleasure of the mayor.
- (c) Each voting member shall be entitled to one (1) vote. The ex-officio and student member shall not have a vote. Any action shall require a majority vote of the members present at a meeting constituting a quorum. A quorum shall consist of at least four (4) voting members.

SECTION 2. EFFECTIVE DATE. This amendment shall become effective November 11, 2024.

SECTION 3. AVAILABILITY. This ordinance may be purchased or inspected in the city clerk's office, Monday through Friday between the hours of 9:00 a.m. and 5:00 p.m.

She said she has approached several people about the issue, but has yet to find resolution.

Tom Manke, 2910 W. M-21, thanked Council for spinning off the Firemen's Memorial Steering Committee. He said they are doing a wonderful job, and he was looking forward to the establishment of a worthy memorial.

Patrice Martin, 615 N. Park Street, spoke about leadership, noting that true leaders serve the people and are not out to burnish their own ego. She celebrated the fact that there are ten candidates running for City Council and encouraged everyone to be open-minded.

Gary Beal, pastor of the Church of Jubilee, said he appreciates each Councilmember and their service to the community. He went on to highlight the service of Mayor Pro-Tem Sue Osika personally thanking her for her dedication to the City and said he has appreciated getting to know the Mayor.

Mayor Teich invited Ms. Hoffman to speak with him about her issue in his office sometime this week, saying he wanted to look into things.

# Parks & Recreation Commission Bylaws Amendment

Motion by Councilmember Pidek approving the proposed amendments to Article 2, Organization, Section 1, Members, of the bylaws of the City's Parks & Recreation Commission as follows:

## **RESOLUTION NO. 176-2024**

# TO AMEND THE PARKS AND RECREATION COMMISSION BYLAWS

WHEREAS, the City of Owosso, Shiawassee County, Michigan, has a Parks and Recreation Commission to provide quality park and recreation opportunities based upon cost, efficiency and community need; and

WHEREAS, the Parks and Recreation Commission is currently made up of 7 members; and

WHEREAS, it is the desire of the Parks and Recreation Commission to add a Student Member to the Commission.

NOW THEREFORE BE IT RESOLVED by the City Council of the City of Owosso, Shiawassee County, Michigan that Article 2, Section 1, Members, shall read as follows:

# **ARTICLE 2: ORGANIZATION**

**SECTION 1: MEMBERS** 

The members of the Commission shall be appointed by the Mayor and approved by the City Council.

The Commission shall consist of seven (7) voting members and two (2) non-voting members as described below:

- a) Seven (7) Voting Members;
- b) One (1) Student Member:
  - I. The Student Member does not have a vote;
  - II. The Student Member shall be between the ages of 15-18, and be enrolled in any public or private high school within the City;
  - III. Student Member term shall consist of one year starting in September.
  - IV. The Student Member shall be entitled to and abide by all applicable rules of procedure pertaining to any meeting of the Commission;
  - V. The Student Member shall be subject to all applicable rules of conduct pertaining to members of the Commission;
  - VI. The Student Member shall retain membership so long as the Student Member is in regular attendance at a high school during the school year which falls within the one-year term;
  - VII. The Student Member's attendance shall not be counted to qualify the Commission's quorum.
- c) One (1) Ex Officio:
  - I. The Ex Officio does not have a vote;
  - II. The Mayor or designee of the Mayor shall be the Ex Officio member of the Commission with Council approval.
